The committee was apprised that Ragging is totally prohibited in college campus and any one found guilty of ragging/abetting whether actively or being a part of conspiracy to promote ragging to liable to be punished in accordance with UGC Regulations 2009 and Haryana Prohibition of ragging Ordinance 2012.

The committee reviewed the measures taken during last year & noted that:

- 1. Anti ragging Committee board should be updated and the number of all the members of anti ragging Committee, Principal, IQAC Coordinator and the district administration should be displayed on the board. Moreover the number of extended committee members should also be mentioned in the list. College email id also be mentioned on the board. All this information shall be updated on college website also. Sh. Sajjan Singh and Dr. Niyti have been asked to update the above information on the board and update the same on college website.
- 2. Anti Ragging Committee be aware with the proctorial duty and if receive any complaint, it must be resolved on priority basis and the culprit should be punished as per UGC and Govt. Rules.
- 3. For 1st year students it is mandatory that they will submit self declaration form and the same be submitted by the parents of the students. The performa is available in the office and on the college website. Dr. Anuradha has been asked to take care of the filling the same related to self declaration by the students.
- 4. Induction Programme should be fxeed and the senior teacher may be asked to address the students regarding ragging and its consequences. Sh. Sajjan Singh,

senior member of the anti ragging Committee has been assigned to take care the induction and counselling of the students by the teachers. Documentary on anti ragging to be shown to students from time to time.

- 5. Institutions shall involve senior faculty members, lady teacher and Persons from Psychology department for counselling the students.
- 6. Mentors be directed to interact with the students at the beginning of the session and during the session to interact with the students
- Principal of the college shall convene the meeting of teaching and non teaching staff in the beginning of the session to bring to their notice all anti ragging measures being taken by the college.
- 8. The teachers shall inform the students through whatsapp group online & in offline mode about the consequences of ragging and ensure that no incident takes place in campus.
